Campaign work within AI50

The entire movement will intensify the work within 5 specific areas: the death penalty, sexual and reproductive health rights in Nicaragua, corporate accountability in the Niger delta, freedom of speech and; international justice and impunity in the Democratic Republic of Congo. The seminar is led by Madelaine Seidlitz, legal adviser, refugees, migrants and international law at AI Sweden.
